PREFACE

The "**CWDS Library Resource Series**" is an attempt to highlight the various aspect of our specialized Library collection relating to women and development studies. The materials available in the Library are in the forms of books and monographs, reports, reprints, conference papers/ proceedings, journals/ newsletters and newspaper clippings.

The present bibliography "Women's Work and Globalisation" presents material on diverse aspects of women's work and employment in the light of changing of economic policies and globalisation.
